
## **Safety Precautions**

- Read these instructions completely before using the equipment.
- Keep these instructions in a safe place.
- Heed all warnings and follow all instructions.
- Sit at least 18" / 45 cm from the monitor.
- When installing the monitor, please leave 4" / 10 cm of open space around the monitor for ventilation safety purposes.
- Always handle the display with care when moving it.
- Always use cabinets or stands or installation methods recommended by the manufacturer of the monitor set.
- Always use furniture that can safely support the monitor.
- Always ensure the monitor is not overhanging the edge of the supporting furniture.
- Do not place the monitor where children are likely to be present.
- Always educate children about the dangers of climbing on furniture to reach the monitor or related equipment.
- Always route and manage cords and cables connected to your monitor so they cannot be tripped over, pulled, or grabbed.
- Exercise caution when removing the rear cover of the monitor. This monitor contains high-voltage parts.
- Do not use this equipment near water. To reduce the risk of fire or electric shock, do not expose the monitor to rain or moisture.
- Avoid exposing the monitor to direct sunlight or other sources of sustained heat.
   Do not install near any heat sources such as radiators, heat registers, stoves, or other devices (including amplifiers) that may increase the temperature of the monitor to dangerous levels.
- Clean with a soft, dry cloth. If further cleaning is required, see the "Maintenance" section in this guide for further instructions.
- Avoid touching the screen. Skin oils are difficult to remove.
- Do not touch, rub, or apply pressure to the monitor screen, as it may permanently damage the screen.
- Do not place the monitor in an unstable location.
- Do not place the monitor on tall furniture (for example, cupboards or bookcases) without anchoring both the furniture and the monitor to a suitable support.
- Do not place the monitor on cloth or other materials that may be located between the product and supporting furniture.

- Place the monitor in a well-ventilated area. Do not place anything on the display that prevents heat dissipation.
- Do not place heavy objects on the display, video cable, or power cord.
- Do not place items that might tempt children to climb, such as toys and remote controls, on the top of the monitor or furniture on which the product is placed.
- If smoke appears, an abnormal noise, or a strange odor is present, immediately switch the display off and contact your dealer or ViewSonic. It is dangerous to continue using the display.
- Do not attempt to circumvent the safety provisions of the polarized or grounding-type plug. A polarized plug has two blades with one wider than the other. A grounding type plug has two blades and a third grounding prong. The wide blade and the third prong are provided for your safety. If the plug does not fit into your outlet, obtain an adaptor and do not attempt to force the plug into the outlet.
- Please confirm the distribution system installed in the building. The system should provide a circuit breaker rated at 120/240V, 20A.
- When connecting to a power outlet, DO NOT remove the grounding prong. Please ensure grounding prongs are NEVER REMOVED.
- Protect the power cord from being treaded upon or pinched, particularly at the plug, and at the point where it emerges from the equipment. Be sure that the power outlet is located near the equipment so that it is easily accessible.
- Only use attachments/accessories specified by the manufacturer.
- Use only with the cart, stand, tripod, bracket, or table specified by the manufacturer, or sold with the equipment. When a cart is used, use with caution when moving the cart/equipment combination to avoid injury from tipping over.
- Unplug this equipment when it will be unused for long periods of time.
- Refer all servicing to qualified service personnel. Service will be required when
  the unit has been damaged in any way, such as: if the power-supply cord or
  plug is damaged, if liquid is spilled onto or objects fall into the unit, if the unit
  is exposed to rain or moisture, or if the unit does not operate normally or has
  been dropped.
- Excessive sound volume from ear-/headphones may cause hearing damage/ hearing loss.
- Adjustment of the volume control as well as the equalizer may increase the ear-/ headphones output voltage and therefore, the sound volume level.
- The factors influencing the ear-/headphones output other than those specified by the manufacturer (e.g. operating system, equalizer software, firmware, driver) may increase the ear-/headphone output voltage and therefore, the sound volume level.

- Stability Hazard: The display may fall, causing serious personal injury or death. To prevent injury, this display must be securely attached to the floor/wall in accordance with the installation instructions.
- Fastening the monitor to a wall or fixed object using cordage or other restraining devices can help support the weight of the monitor in order to prevent the monitor from falling over.

#### Note:

- Restraining device/cordage should be able to withstand 100N force.
- Make sure the cordage is straightened, and any slack is removed. The back
  of the device shall face the wall to ensure the device cannot tilt under
  external force.
- Make sure the monitor does not tilt under external force at any height and rotation angle of the device.
- If the existing monitor is going to be retained and relocated, the same considerations as above should be applied.



## **Installing the Stand**



**Note:** Place the monitor on a flat, stable surface to ensure safety and optimal performance.

## **Removing the Stand**



**Important:** Before removing the stand, turn off the monitor, disconnect all cables, and place the monitor on a flat, stable surface with the screen facing down.


## **Mounting the Monitor**

After removing the stand, the monitor can be mounted using an optional mounting kit.

**Note:** For use only with a UL certified mounting kit. To obtain a mounting kit or height adjustment base, contact ViewSonic® or your local dealer.



- **1.** Attach the mounting bracket to the VESA mounting holes at the rear of the monitor, securing it with four M4 x 10 mm screws.
- **2.** Follow the mounting kit instructions to mount the monitor.

## **Using the Security Slot**




To help prevent the monitor from being stolen, use a security slot locking device to secure the monitor to a fixed object.

Additionally, fastening the monitor to a wall or fixed object using a security cable can help support the weight of the monitor in order to prevent the monitor from falling over.





## **Adjusting the Viewing Angle**

## **Height Adjustment**


Lower or raise the monitor to the desired height (0 to 150 mm).




**Note:** When adjusting, press down firmly along the adjustment track holding the monitor with both hands on the side.

### **Screen Orientation Adjustment (Monitor Pivot)**

**1.** Adjust the monitor height to the highest position. Then tilt the monitor backwards to the full tilt position.



**2.** Rotate the monitor 90 degrees clockwise or counterclockwise from landscape to portrait orientation.




#### Note:

- When adjusting, make sure to hold both sides of the monitor firmly with both hands.
- To rotate the screen image, manually change the system's display orientation settings.


## **Swivel Angle Adjustment**

Swivel the monitor to the left or right for the desired viewing angle ( $\pm$  30 $^{\circ}$ ).



## **Tilt Angle Adjustment**


Tilt the monitor forwards or backwards to the desired viewing angle (-5° to 25°).



**Note:** When adjusting, support the stand firmly with one hand while tilting the monitor forwards or backwards with the other hand.

## **Turning the Monitor On/Off**


**Note:** The monitor will still consume power as long as the power cord is plugged in. If the monitor is not being used for extended periods, please unplug the power cord from the power outlet.



- **1.** Plug the connected power cord into a power outlet.
- 2. Press the **Power** button to turn on the monitor.
- **3.** To turn the monitor off, press the **Power** button again.


## **Using the Joy Key**

Press or move the **Joy Key**  $(\uparrow/\downarrow/\leftarrow/\rightarrow)$ to activate the Quick Menu.












## **Configuring the Settings**

### **General Operations**




**2.** Move the **Joy Key**  $(\leftarrow/\rightarrow)$  to select the main menu. Then move the **Joy Key**  $(\downarrow)$  to enter the selected menu.



**3.** Move the **Joy Key**  $(\uparrow / \downarrow)$  to select the menu option. Then move the **Joy Key**  $(\rightarrow)$  to enter the sub-menu.



**4.** Move the **Joy Key** ( $\uparrow/\downarrow$ ) to select the setting. Then press the **Joy Key** to confirm, or move the **Joy Key** ( $\leftarrow/\rightarrow$ ) to make adjustments.

## **Glossary**

This section describes the standard glossary of terms used in all LCD display models. All terms are listed in alphabetical order.

**Note:** Some terms may not be applicable to your monitor.

### Advanced DCR

Advanced DCR technology automatically detects the image signal and intelligently controls the backlight brightness and color to improve on the ability to make the black blacker in a dark scene, and make the white whiter in a bright environment.

### **Audio Adjust**

Adjusts the volume, mutes the sound, or toggles between inputs if you have more than one source.

#### **Auto Detect**

If the current input source has no signal, the monitor will automatically switch to the next input option. This function, on some models, is disabled by default.

#### **Auto Image Adjust**

Automatically sizes, centers, and fine tunes the video signal to eliminate waviness and distortion.

## **B** Blue Light Filter

Adjusts the filter that blocks high-energy blue light for a more comfortable viewing experience.

### **Brightness**

Adjusts background black levels of the screen image.

#### Color Adjust

Provides several color adjustment modes, to help adjust the color settings to fit the user's needs.

#### **Color Space**

Allows users to choose which color space they would like to use for monitor color output (RGB, YUV).

#### **Color Temperature**

Allows users to select specific color temperature settings to further customize their viewing experience.

<b>Panel Default</b>	Panel Original Status
sRGB	Standard color space used for the Windows system.
Bluish	Set the color temperature to 9300K.
Cool	Set the color temperature to 7500K.
Native	Default color temperature. Recommended for general use.
Warm	Set the color temperature to 5000K.

#### **Contrast**

Adjusts the difference between the image background (black level) and the foreground (white level).

#### Information

Displays the timing mode (video signal input) coming from the graphics card in the computer, the LCD model number, the serial number, and the ViewSonic® website URL. See your graphics cards's user guide for instructions on changing the resolution and refresh rate (vertical frequency).

**Note:** VESA 1024 x 768 @ 60Hz, for example, means that the resolution is 1024 x 768 and the refresh rate is 60Hz.

#### **Input Select**

Toggles between the various input options that are available for the monitor.

### Manual Image Adjust

Displays the "Manual Image Adjust" menu. You can manually set a variety of image quality adjustments.

#### **Memory Recall**

Returns the adjustments back to factory settings if the display is operating in a factory preset timing mode listed in the "Specifications" of this manual.

**Note:** (Exception) This control does not affect changes made in the "Language Select" or "Power Lock" setting.

#### Overscan

Refers to a cropped image on your monitor's screen. A setting on your monitor zooms in on movie content, so that you cannot see the outermost edges of the film.

## **R** Recall

Resets the ViewMode monitor settings.

#### **Resolution Notice**

The notice tells users that the current viewing resolution is not the correct native resolution. This notice will appear in the display settings window when setting up the display resolution.

### **Response Time**

Adjusts the response time, creating smooth images without streaking, blurring, or ghosting. A low response time is perfect for the most graphic-intense gaming, and provides amazing visual quality while watching sports or action movies.

### **S** Setup Menu

Adjusts On-Screen Display (OSD) Menu settings. Many of these settings can activate on-screen display notifications so users do not have to reopen the menu.

#### **Sharpness**

Adjusts the picture quality of the monitor.

#### ViewMode

ViewSonic's unique ViewMode feature offers "Game", "Movie", "Web", "Text", "MAC", and "Mono" presets. These presets are specifically designed to deliver an optimized viewing experience for different screen applications.

## 1 1ms Mode <MPRT>

Choose whether to activate Moving Picture Response Time (MPRT); default setting is Off.

#### Note:

- Make sure Input Timing detection is ≥ 100 Hz to turn on 1ms Mode from default.
- If 1ms Mode is set to "On", when turning on FreeSync, MPRT will automatically turn off.
- When 1ms Mode is set to "On", the following functions will be grayed out and disabled: Brightness, Advanced DCR, Eco Mode, Response Time, DDC/CI Brightness adjustment.
- The IC controls Moving Picture Response Time, so the overall Brightness will be dark.

## **Troubleshooting**

This section describes some common problems that you may experience when using the monitor.

Problem or Issue	Possible Solutions
No power	<ul> <li>Make sure you have turned on the monitor by pressing the Power button.</li> <li>Make sure the power cord is properly and securely connected to the monitor and power outlet.</li> <li>Plug another electrical device into the power outlet to verify that the outlet is supplying power.</li> </ul>
Power is On, but no image appears on screen	<ul> <li>Make sure the video cable connecting the monitor to the computer is properly and securely connected.</li> <li>Adjust the brightness and contrast settings.</li> <li>Make sure the correct input source is selected.</li> </ul>
Wrong or abnormal colors	<ul> <li>If any colors (red, green, or blue) are missing, check the video cable to make sure it is properly and securely connected. Loose or broken pins in the cable connector could cause an improper connection.</li> <li>Connect the monitor to another computer.</li> </ul>
Screen image is too light or dark	<ul> <li>Adjust brightness and contrast settings via the OSD Menu.</li> <li>Reset the monitor to factory settings.</li> </ul>
Screen image cuts in and out	<ul> <li>Make sure the correct input source is selected.</li> <li>Check for bent or broken pins in the video cable connector.</li> <li>Make sure the video cable connecting the monitor to the computer is properly and securely connected.</li> </ul>
Screen image is blurred	<ul> <li>Adjust the resolution to the correct Aspect Ratio.</li> <li>Reset the monitor to factory settings.</li> </ul>
The screen isn't centered correctly	<ul> <li>Adjust the horizontal and vertical controls via the OSD Menu.</li> <li>Check the Aspect Ratio.</li> <li>Reset the monitor to factory settings.</li> </ul>
The screen appears yellow	Make sure the "Blue Light Filter" is Off.

Problem or Issue	Possible Solutions
The OSD Menu does not appear on the screen/the OSD controls are inaccessible	<ul> <li>Check whether the OSD Menu is locked.</li> <li>Turn off the monitor, unplug the power cord, plug it back in, and then turn on the monitor.</li> <li>Reset the monitor to factory settings.</li> </ul>
Control panel keys do not work	<ul><li>Press only one key at a time.</li><li>Restart the computer.</li></ul>
Some menus aren't selectable in the OSD	<ul><li>Adjust the ViewMode or the input source.</li><li>Reset the monitor to factory settings.</li></ul>
